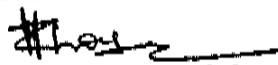

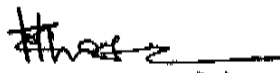

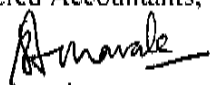
Review Report to the members of Emerald Leisures Limited
